## NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the GOVERNING BOARD of the SAN YSIDRO SCHOOL DISTRICT, at its regularly scheduled meeting to be held on December 14, 2017, will conduct a public hearing, and receive public testimony on the 2014-2015, 2015-16 and 2016-17 Annual and Five Year Reports. The School District currently collects statutory school fees pursuant to Sections 17620 et seq. of the Education Code and Sections 65995 et seq. of the Government Code.
