STATE MAY REVISE BUDGET 2020-2021

The coronavirus induced recession catapulted our nation, the state and education into an unprecedented economic tsunami. Since the March Stay-at-Home Order our district schools have served as beacons of hope for our community during this difficult time by serving over 24,000 meals per week to all children ages 1-18 and by launching an academic Distance Learning Program paired with virtual tutoring. Schools are being asked to do dramatically more without the necessary resources and funding required to purchase protective equipment, disinfection products, technology devices and internet for students, professional development for staff, and more. The devastating budget reductions to education projected by the Department of Finance and in the state's May Revise Budget are the largest cuts to education over a two year period of time that many of us will ever see in our lifetime. The monumental size of the cuts will topple education and severely handicap the ability of schools to safely reopen and provide a quality education to California's children.

SB 1058 (HUES0) - THE DIGITAL DIVIDE RELIEF PLAN

It was an honor for our district along with the Sweetwater Union High School District to be invited to join Senator Hueso in speaking at a press conference regarding his proposed legislation SB 1058 - The Digital Divide Relief Plan on Friday, May 15th at Hilltop High School. This legislative bill ensures that vulnerable populations in California have reliable, accessible and affordable access to the internet to access essential services such as medical, public assistance and education during emergencies like the current coronavirus pandemic.

In March, when our schools physically closed for the safety and health reasons and pivoted to a distance learning online academic program a district survey of our schools indicated that over 50% of our students did not have a device and/or internet at home to access their online Google Classroom portals. Thus, the children of our community did not have equitable access to the essential technology needed to engage in an online learning portal. Senator Hueso's valiant efforts to close the digital divide that exists in communities like ours throughout our community is most appreciated! A special thanks to Board Member Irene Lopez for speaking with the media alongside Senator Hueso, SUHSD Superintendent Karen Janney and SYSD Superintendent Dr. Gina Potter in strong support of SB 1058.

COALITION OF EDUCATORS TO RALLY IN SUPPORT OF SENATOR HUESO'S URGENCY BILL TO ADDRESS CALIFORNIA'S DIGITAL DIVIDE

SAN DIEGO – Senator Ben Hueso (D-San Diego) will be joined by representatives of the Sweetwater Union High School District and San Ysidro School District for a press conference discussing his urgency bill to address the digital divide in California, especially in light of COVID-19 and schools switching to online learning.

Senate Bill No. 1058, the Digital Divide Relief Plan, aims to ensure that all Californians, especially vulnerable populations, have reliable and accessible access to telecommunications resources necessary to obtain essential services during emergencies, including ongoing efforts to address the COVID-19 pandemic. As doctor's consultations, unemployment applications, public assistance, enrollment, and education have moved online, the inability to access broadband has limited Californians' ability to obtain resources and information necessary for public health and safety.

SB 1058 would require the California Public Utilities Commission to take urgent action to direct internet service providers to file emergency operations plans that identify how they will coordinate with emergency responders, ensure reliable communications during a disaster or emergency, and deploy resources and technology to ensure that communications remain reliable. These plans must be updated annually and must include information about how each company intends to invest in expanding broadband. Importantly, the bill will also require the companies to identify an affordable internet plan that they will offer to those impacted by a disaster or emergency, including those who must shelter-in-place during a pandemic.
