AGENDA ITEM: PUBLIC HEARING FOR PROPOSED BUDGET FOR FISCAL YEAR 2022-23

BACKGROUND INFORMATION:

In accordance with the provisions of the Education Code Section 42103, each year the District is required to adopt a budget for the next fiscal year. The budget must be reviewed during a public hearing and the Board must consider any written comments received prior to the public hearing. The budget includes the budget assumptions, identifies the anticipated general fund revenues and expenditures, the fund balances of other District funds and multi-year projections.

A Notice of Public Hearing was published on the San Diego Union Tribune on May 13, 2022. The proposed budget was made available for public inspection on June 6 to June 8, 2022. The District is requesting that a public hearing be conducted for any interested parties to comment on the 2022-23 Proposed Budget which will be presented for approval/adoption at its next regular Board meeting to be held on June 23, 2022
